2026 Golf Season Pass

It is important to Innsbrook to recognize the tradition and values of our community while continuing the work to make Innsbrook even better. Throughout the past several years, Innsbrook's ownership and management team have made great strides in improving not only the golf course, but also the clubhouse and facilities. 2025 has seen the continuation of this work with the removal of trees, the addition of new forward tees, laser leveling tees, re-sodding, drainage work, bunker improvements, overseeding the greens and rough, and much more. In 2026 you will see even more of this including expanded Par Bar hours, more events and music at the Par Bar!

All Season Passes include unlimited greens fees, cart fees, and range balls for the calendar year 2026, and advance tee time reservation requests. **In addition, Innsbrook Pass holders will have reciprocal privileges at the following Walters Golf Management* golf courses: Gateway National Golf Links, Far Oaks Golf Club, Stonewolf Golf Club, Woods Fort, and Heritage at Hawk Ridge Golf Club.** Reciprocal rates at any of these courses will be at preferred pass holder pricing. All tee times made at reciprocal courses must go through the Innsbrook golf shop within one day of the tee time (weekend/holiday play must be after 1:00 p.m.). If your tee time is not booked through the Innsbrook golf shop you will be charged the regular applicable rates at each facility.

The club reserves the right to close the course at any time for outside bookings/events. ***Season passes are not valid for booked events (corporate outings, charity outings, or Innsbrook sponsored events). All pass holders must abide by the rules set forth and check in prior to each round (checking in will be strictly enforced).***
